Registration to perform with the Tango Times Dance Company:

The Tango Times Dance Company performs Argentine Tango and Argentine Folk Dances.

Requests:

- 1- Each member of the Tango Times Dance Company is required to take, at least, one Argentine Tango Lesson and one Argentine Folk Lesson at the Tango Times Dance Studio.
- 2- Each member of the Tango Times Dance Company is required to be present at rehearsals. Rehearsals are being held usually but not exclusively Saturdays from noon until 3pm.
- 3- Periodically The Tango Times Dance Company will take pictures and/or videos during lessons, performances and rehearsals for publications. By signing this release you agree to have your image taken and used for publication. These images belong to the Tango Times Dance Company.
- 4- The choreographies are property of the Tango Times Dance Company.

Generals:

- 1- Dancing is a corporal activity that may injure your body. In this regard please consider that Tango Times Dance Company and/or staff are not liable for injuries sustained or illnesses contracted by the student while attending classes, performances or rehearsals. Verify with your doctor whether you may attend dancing lessons.
- 2- Group Lessons are being held as scheduled and are subject to change. Depending on the kind of dance, Classes last one hour, one hour and a half or two hours.
- 3- The cost of each group lesson depends on the specific dance. In general and as of February 1<sup>st</sup> 2010, cost for group lessons is \$ 15.00 (fifteen dollars) for single lesson or \$60.00 (sixty Dollars) for a 5 lessons card. The cost of each class is subject to changes.
- 4- You are free to take as many lessons as you want. It is your own responsibility the frequency of which you come to class.
- 5- You are the sole responsible for your belongings.
- 6- Periodically Tango Times Dance Company will take photos and/or videos during Lessons, Performances and Rehearsals for publications. Sometimes the name of the student will identify the images.

Specifics for Argentine Tango:

The Tango Dance is a close embrace dance which compromises the connection between partners. By taking Tango Lessons you agree to the following terms and conditions:

1. Hygiene is very important.
2. You will be asked to dance with other students,
3. Corrections of the body position will involve movements and contacts that could be misunderstood, in this item, when you feel uncomfortable you must indicate so in that moment, otherwise you'll be agreeing with the teaching technique
4. You will advance in your dancing level depending on the frequent of your class attending,
5. You are the sole responsible for your belongings,
6. You are not obliged to attend all the classes given at the Studio; participation is of your own responsibility.

7. Dress comfortable, women should have closed high hills shoes, men should have soil shoes (no rubber).

Specifics for Dance Technique:

1. Dress Comfortable: Gym pants and a T-shirt. We suggest you bring a pair of socks and / or ballet dance shoes.
2. We remind you that this is a strong workout.

Specifics for Ballroom Dances:

- 2- Tango Times Dance Company is Registered with the State of Florida as a Ballroom Dance Studio Registration Number:
- 3- If there is an advanced payment for multiple lessons
- 4- A provision for the penalty-free cancellation of the contract within 3 days, exclusive of holidays and weekends, of its making, upon the mailing or delivery of written notice to the ballroom dance studio. Written notice may be construed as any written expression of the customer to not be bound by the contract. The ballroom dance studio shall refund upon such notice all moneys paid under the contract except the amount for ballroom dance studio services or lessons actually rendered or to have been rendered, by contract, during the number of days prior to the cancellation notice. A refund shall be issued within 20 days after receipt of the notice of cancellation made within the 3-day notice.
- 5- A provision for the cancellation of the contract, if the buyer dies or becomes physically or mentally unable to avail himself of the dance studio lessons or services or if the lessons or services cease to be offered as stated in the contract, after 3 business days of its making and release from further payments upon notice of cancellation. After three business days the studio shall charge only for the dance instruction and dance instruction services actually furnished under the agreement plus a reasonable and fair service fee. The studio shall refund the balance in three equal monthly installments, to be completed within not more than ninety days after receiving notice of cancellation.

“Reasonable and fair service fee” means no more than 10 percent of the total contract price for contracts of \$1,000 and under. For contracts over \$1,000, “reasonable and fair service fee” shall mean no more than \$100 plus an amount equal to 5 percent of the total contract price over \$1,000 (not to exceed \$250 in total).
